- 1. August Meeting Minutes approved as submitted.
- 2. DSA Report, Greg Dombrowski
 - a. Greg presented his 2018-19 budget.
 - i. It is very similar to previous year.
 - ii. Gate revenue was decreased due to the increased booster membership (about \$5000 less than last year.)
 - b. Greg provided the most recent fall sports' schedules
 - i. Michele will update the Sign-Up Genius
 - c. Greg announced that the Fairfax County activity fee went away for the 2018-19 season.
 - d. There is a new uniform rotation this year: cross country (girls and boys); cheer (split with team); boys and girls basketball.
 - e. Gunston District gate fee went to \$6.00; students paid \$5.00.
 - i. National district did not increase fees.
 - f. Greg wanted to recognize the Hakenson family who painted the baseball dugouts over the Labor Day weekend. They look great.
 - g. Greg met with Ms. Brumfield regarding the dugout renovation. There is still no notification from the county on the status of their assessment.
 - h. Greg informed Boosters that there is a mattress fundraiser that could be considered. The sales representative has been in regular contact with Greg for consideration of this fundraiser.
 - i. Hayfield earned \$7500 on this event in the past.
 - ii. Kristyna asked to get in touch with the Hayfield parent who ran the event.
 - iii. This discussion is tabled until more information is gathered.
- 3. Treasurer's Report, Paul Trimber
 - a. The report given was transactions through August 31, 2018.
 - b. Paypal accounts consist of booster memberships and craft fair purchases.
 - i. There is currently about \$9000 in pending transactions
 - c. Biggest expense so far is for fall concession stand inventory.
 - d. Weight room will be added to the team accounts.

- 4. Concessions Report, Michele Weinstein Bessenger
 - a. Volleyball, field hockey and football concessions are active.
 - i. Hayfield football game concessions were very successful.
 - ii. Volleyball gates are good and are having good revenues.
 - b. Concession SUG slots are being filled.
 - c. All coaches have been given tickets (worth \$5.00) to be used as they wish for concession purchase.
 - i. Redeemed tickets are marked by sport and when redeemed will be deducted from team accounts.
- 5. Membership Report, Tina Schulz
 - a. Total members to date: 375
 - i. Student passes: 125
 - b. Tina will send Greg information to be included with morning announcements.
- 6. Operations Report, Carilyn Waterval
 - a. Craft fair registration is open for crafters.
 - b. Tracy will include in the weekly booster message for the next month or so.
 - c. Early bird price is \$65 per table; discount given to Edison alumni, parent, etc.
 - d. Date: November 10
 - e. This is a decent fundraiser for boosters, 2017 was about \$4800
 - f. Teams that provide set up or tear down earn \$200 for their team.
- 7. Communications Report, Tracy Brown
 - a. Trace is sending the weekly Eagle blast.
 - i. It is being sent to last year's list and this year's list.
 - ii. It will be sent only to current member's in the coming weeks.
 - b. Mailchimp shows statistics on open rates our current read rate is 41%.
